ARTICLE OF INCORPORATION

OF

INTERNATIONAL JUDICIAL INVESTIGATION, INC.
(INVESTIGACIONES JURIDICAS INTERNACIONALES, INC.)

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be, INTERNATIONAL JUDICIAL INVESTIGATION, INC. (INVESTIGACIONES JURIDICAS INTERNACIONALES, INC.)

ARTICLE II
DURATION

This corporation is to have perpetual existence.

ARTICLE III
NATURE OF BUSINESS

The purpose of this corporation is to engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
CAPITAL STOCK

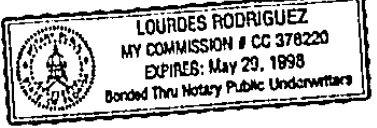

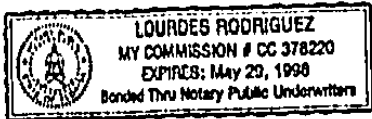
