ARTICLE I
NAME

The name of this Corporation is SKYCREST CHILD DEVELOPMENT CENTER, INC.

ARTICLE II
PURPOSES

PERPETUAL EXISTENCE

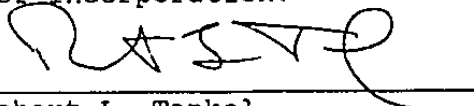
This Corporation shall have perpetual existence unless sooner dissolved as provided by law.
