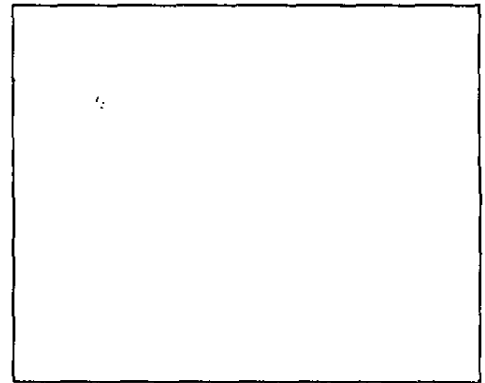



The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of ALEXIM TRADING CORPORATION pursuant to Section 607.1006 of the Florida Statutes.

1. The name of the Corporation is ALEXIM TRADING CORPORATION.
2. The date of the filing of the Articles of Incorporation was January 13, 1995 and assigned Document No. P95000003724.
3. The Articles of Incorporation shall be amended to remove the following:
 - a) "Enrique E. Bustamante shall hold 49% of the shares of mentioned corporation. Rosa Bustamante shall hold 51% of the shares of mentioned corporation."
 - b) In all other respects, the Articles of Incorporation shall remain unchanged.
4. This Amendment was adopted by a written statement signed by all of the shareholders and directors of ALEXIM TRADING CORPORATION on the 6 day of May, 2015, pursuant to Section 607.1003 of the Florida Statutes.
