ARTICLE I -- NAME

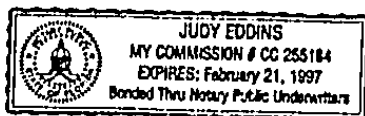


