

EFFECTIVE DATE The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida:

ARTICLE I. CORPORATE NAME

The name of this Corporation is:

NMT LATIN AMERICA, INC.

ARTICLE II. MAILING ADDRESS OF CORPORATION

ARTICLE III. CAPITAL STOCK
