ARTICLES OF INCORPORATION  
OF  
THE ASSEMBLY PLACE, INC.

ARTICLE I - NAME

The name of this Corporation is THE ASSEMBLY PLACE, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 200,000 shares of common stock.

ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE

The principal office of this Corporation shall be 3615 NW 13th Street, Suite A, Gainesville, Florida 32609, and the initial registered agent of this Corporation at such office shall be Frank Masyada, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of four members. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than One (1) nor more than Ten (10). 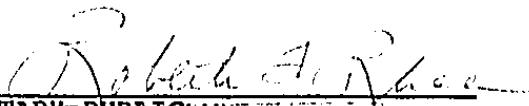
