ARTICLES OF INCORPORATION
OF
LANCELOT COMICS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be LANCELOT COMICS, INC.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of this corporation shall be: 15000 D S.W. 49th Lane, Miami, Florida 33185. The address of the corporation shall be the same.

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation with the Secretary of State. This corporation's duration shall be perpetual.

ARTICLE IV. PURPOSE
