ARTICLES OF INCORPORATION

OF

ANNETTE CONCEPTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**Article 1: Name.** The name of the Corporation is ANNETTE CONCEPTS, INC.

**Article 2: Duration.** The duration of the Corporation is perpetual.

**Article 3: Purpose.** The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish th

**Article 4: Capital Stock.** The Aggregate number of Shares which the Corporation is authorized to issue is 100 (One Hundred) shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar per share. The initial Shareholder is Annette Scherman, who holds 100 shares.

**Article 5: Principal Office, Initial Registered Office, and Agent.** The street address of the principal office and initial registered office of the Corporation is 1625 Treehouse Circle, #T-111, Sarasota, Florida, 34231, and the name of the initial Registered Agent at that address is Annette Scherman.

**Article 6: Initial Board of Directors.** The number of Directors constituting the initial board of Directors is One. The number of Directors may be increased or decreased from time to time in accordance with the bylaws but shall never be less than One. The name and address of the initial director of the Corporation is as follows: Annette Scherman, 1625 Treehouse Circle, #T-111, Sarasota, Florida, 34231.

**Article 7: Incorporator.** The name and address of the incorporator is Annette Scherman, 1625 Treehouse Circle, #T-111, Sarasota, Florida, 34231.

Article 8: Amondment. The Corporation reserves the right to amond or repeal any provisions containd in the Articles of Incorporation or any amondment to them. The right conferred upon the shareholders is subject to this reservation.

Article 9: Indemnification. The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

Article 10: Bylaws. The power to adopt, alter, amend, and repeal Bylaws shall be vested in the Board of Directors, but all alterations, amondments, and repeals of the Bylaws must be approved by a majority of the Shareholders.

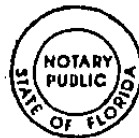
