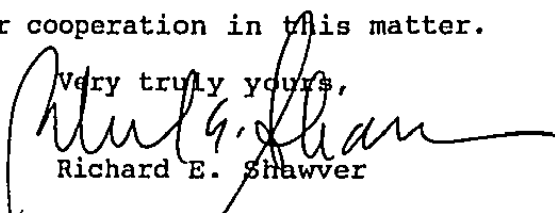

Articles of Incorporation

of

Martin County Class of 1985, Inc.

Article 1 - Name. The name of the corporation shall be
Martin County Class of 1985, Inc.

Article 2 - Duration. This corporation shall have perpetual
existence, commencing on the date of the filing
of these Articles of Incorporation with the
Department of State, State of Florida.

Article 3 - Purpose. This corporation is organized for the
purpose of coordinating class reunions for the
class graduated June 7, 1985 at the Martin County
High School. In fact, this corporation shall be
empowered to transact any of all lawful business
for which corporations may be formed under
Chapter 607, Florida Statutes, as it now may
exist, or may later be amended.

Article 4 - Stock. The corporation is authorized to issue
100 shares of no par value common stock,
hereinafter designated as the "common shares".

Article 5 - Pre-Emptive Rights. Every shareholder, upon
the sale of any stock of this corporation for
cash, shall have the right to purchase his or her
pro-rata share thereof (as nearly as may be done
without issuance of fractional shares) at the
price at which it is offered to others.

Article 6 - Initial Registered Office & Agent. The street
address of the initial registered office of the
corporation will be 1274 NE Business Park Place,
Jensen Beach, Florida 34957, and the name of the
initial registered agent of the corporation at
that address is Richard E. Shawver.

Article 7 - Initial Board of Directors. The corporation shall have six Directors constituting the initial Board of Directors. The number of Directors may be increased or decreased by the By-Laws, from time to time; however, there shall never be less than two Directors, nor more than seven Directors. 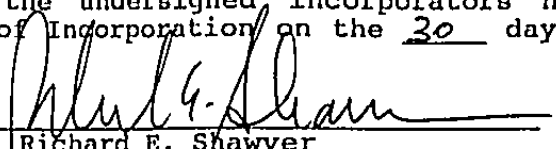

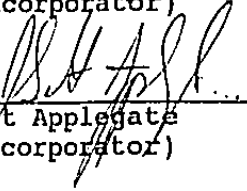
Article 9 - Indemnification. The corporation shall fully indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

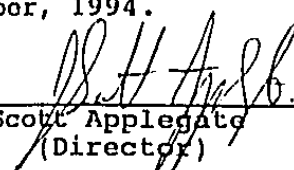

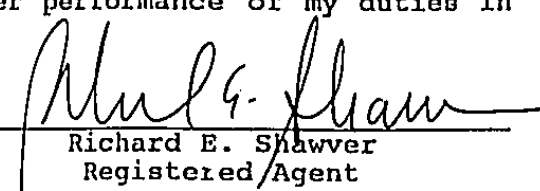

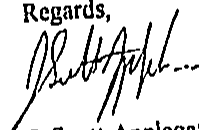
