The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation shall be F.M.10, Inc.

ARTICLE II

ARTICLE III

NATURE OF BUSINESS: This corporation shall be organized for the purpose of transacting any and all lawful business.

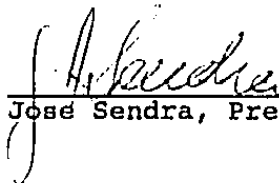
ARTICLE X

The undersigned incorporator has executed these Articles of Incorporation this 9th day of January, 1995.

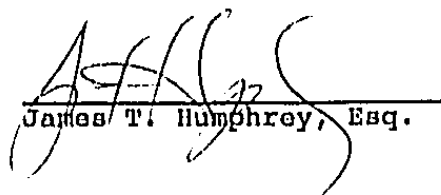
