The undersigned, as President of First Coast Cable Enterprises Inc., a Florida corporation, files these Articles of Dissolution for the corporation and states the following:

- 1. The name of the corporation being dissolved is First Coast Cable Enterprises Inc.
- 2. The Articles of Incorporation for this corporation were filed with the Florida Department of State, Division of Corporations, on January 18, 1995, was assigned Document Number P95000004366 at that time.
- 3. On March 28, 1995, the Board of Directors for the corporation authorized this dissolution at a special called meeting, for which notice was waived by all directors.
- 4. The sole remaining shareholder for the corporation approved the dissolution of the corporation on March 28, 1995, by her written consent in lieu of a special called meeting of the shareholders of the corporation.
