ARTICLES OF INCORPORATION

of

DISCOUNT TOBACCO SALES, INC.

WE, the undersigned, hereby associat ourselves for the purpose of becoming a corporation under the laws of the State of Florida, and under the statute of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of incorporating for profit, it is:

ARTICLE 1

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE 11

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE 111

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock, and which common stock whatk when have a par value of \$ 1.00 per share).

All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the By-Laws or written agreement amongst the stockholders which shall be on file in the office of the offices of the corporation so named in Article VII herein.

The By-Laws may provide for cumulative voting by stockholders at all elections of the directors of the corporation.
