# ARTICLES OF INCORPORATION OF

TCN OF FLORIDA CORPORATION

95 JAN 17 PH 2: 10

The undersigned, being a natural person of the age of eighteen (18) years or more, acting as the incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is TCN of Florida Corporation (the "Corporation"). With the principal address of the corporation at:
12377 Merit Drive., Ste. 100, Dallas, TX 75251.
ARTICLE II

The period of its duration is perpetual.

# ARTICLE III

The purpose for which the Corporation is organized is to transact any and all lawful business for which Corporations may be incorporated under the Florida General Corporation Act.

#### ARTICLE IV

The street address of the initial registered office of the Corporation is 1200 South Pine Island Road, Plantation, Florida 33324, and the name of the initial registered agent of the Corporation at such address is CT Corporation System.

#### ARTICLE V

The Corporation is authorized to issue one class of capital stock to be designated Common Stock. The aggregate number of shares which the Corporation shall have authority to issue is Ten Million (10,000,000) shares of Common Stock, (\$0.01) par value.

### ARTICLE VI

Cumulative voting in the election of directors is expressly prohibited.

# ARTICLE VII

No shareholder of the Corporation shall by reason of his holding shares of stock of the Corporation have a preemptive or preferential right to acquire additional, unissued, or treasury shares of any class or series of stock of the Corporation, or securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares, whether such shares he now or hereafter authorized.

#### ARTICLE VIII

The Corporation will not commence business until it has received for the issuance of its shares consideration of the value of One Thousand Dollars (\$1,000.00), consisting of money paid, labor done, or property actually received.

### ARTICLE IX

The number of directors shall be fixed in the manner provided in the Bylaws of the Corporation. The initial Board of Directors will consist of three (3) directors, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

## ARTICLE X

To the fullest extent permitted by Florida statutory or decisional law, as the same exists or may hereafter be amended or interpreted, a director of the Corporation shall not be liable to the Corporation or its shareholders for any act or omission in such director's capacity as a director. Any repeal or amendment of this Article, or adoption of any other provision of these Articles of Incorporation inconsistent with this Article, by the shareholders of the Corporation shall be prospective only and shall not adversely affect any limitation on the liability to the Corporation or its shareholders of a director of the Corporation existing at the time of such repeal, amendment, or adoption of an inconsistent provision.

# ARTICLE XI

Any action which may be taken at any annual or special meeting of shareholders may be taken without a meeting, without prior notice, and without a vote, if one or more written consents, setting forth the action so taken, is signed by the holders of shares having not less than the minimum number of votes necessary to take such action at a meeting at which the holders of all shares entitled to vote on the action were present and voted.
