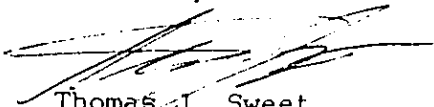

ARTICLES OF INCORPORATION

ARTICLE I-NAME The name of this corporation is: TOMCO TECH, INC.

ARTICLE II-DURATION The corporation shall have a perpetual existence.

ARTICLE III-PURPOSE The general purpose of the corporation is to engage in the business of manufacturing, distribution, and related activities, and any other business and commercial activities and business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV-CAPITAL STOCK The minimum number of shares which this corporation is authorized to issue and have outstanding at any time is 1000 shares of common stock having a par value of NO PAR VALUE per share.

ARTICLE V-PRINCIPAL OFFICE AND INITIAL REGISTERED OFFICE AND AGENT The principal office of the corporation shall be 2532 Hibiscus Drive, Edgewater, Florida, 32141-5004 and the initial registered office of this corporation shall be Thomas J. The extent of the pre-emptive rights is determined by the ratio of the total authorized and issued shares to the total of such shares owned by any holder.

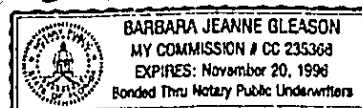
