### ARTICLES OF INCORPORATION

ARTICLE I

SS JEN 17 AND: 02

The name of the corporation shall be LEE FRY, INC., a Florida corporation.

### ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
