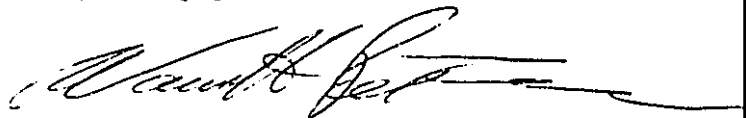

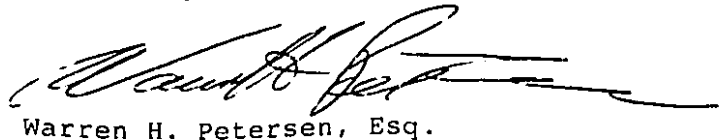

ARTICLES OF INCORPORATION  
OF  
DoRite Communications, Inc.

The undersigned, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be DoRite Communications, Inc.

ARTICLE II

The general nature of the business shall be any lawful business.

ARTICLE III

The post office address of the principal office of this corporation shall be 4905 Old Oak Trail, St. Cloud, Florida, 34771.

ARTICLE IV

This corporation shall commence upon compliance with the requirements of Florida law, and shall be perpetual.

ARTICLE V

The amount of capital stock authorized is five hundred (500) shares, all common stock, at a par value of One Dollar (\$1.00) per share.

ARTICLE VI

Each share of stock shall be entitled to one vote.

ARTICLE VII

The amount of capital with which this corporation will begin business shall be Five Hundred Dollars (\$500.00).

#### ARTICLE VIII

This corporation shall have one (1) director initially. The number of Directors may be increased or diminished from time to time, by by-laws adopted by the stockholders, but shall never be more than three (3).

#### ARTICLE IX

The name and post office address of the first member of the Board of Directors is:

#### ARTICLE X

These Articles of Incorporation may be amended in the manner provided by law. Each amendment shall be approved by the Board of Directors, proposed by them to the Stockholder's meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the Stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

#### ARTICLE XI


Clifford Beckel, 4905 Old Oak Trail, St. Cloud, FL 34771, is hereby designated as the agent upon whom service of process may be served.

#### ARTICLE XII

The foregoing Articles of Incorporation are to be construed as independent objects, purposes and powers in the operation of this corporation and all in furtherance and not in limitation of the general powers conferred by the laws of the State of Florida

upon corporations organized thereunder, and the enumeration of these specific powers set forth in these Articles shall not be construed to limit or restrict in any manner the general powers of this corporation as conferred upon it by the law of statutes of the State of Florida.
