OF

The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby certifies these Articles of Incorporation to form a corporation under the laws of the State of Florida.

First: The name of the corporation shall be NARROFLEX (MIAMI), INC. (the "Corporation").
