ARTICLES OF INCORPORATION
OF
COMMUNITY RESOURCE ADVISORS, INC.

The undersigned incorporator of COMMUNITY RESOURCE ADVISORS, INC. pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is COMMUNITY RESOURCE ADVISORS, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation is to commence upon the filing of these Articles with the Secretary of State.

ARTICLE III. PURPOSE

The corporation is organized for purposes of managing loans and other transactions for Community Resource Associates, Inc., and transacting any other lawful business.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 100,000 shares of participating and voting \$.01 par value common stock. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE V. INITIAL REGISTERED AND PRINCIPAL OFFICE AND AGENT

ARTICLE VI. INITIAL BOARD OF DIRECTORS
