ARTICLES OF INCORPORATION

OF

DNI, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be DNI, INC., and the initial address of this corporation shall be 1927 SE 23rd Avenue, Fort Lauderdale, Florida 33316.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.
