ARTICLE XIII. SPECIAL PROVISIONS

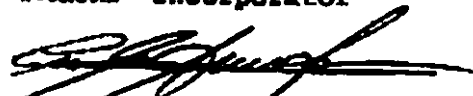
It is the intent of the incorporators that the corporation will qualify under Section 1244 of the Internal Revenue Code.

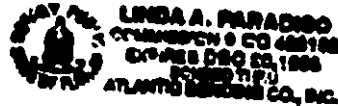

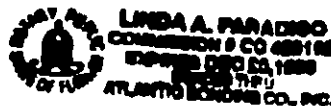
