ARTICLE I. NAME

The name of this corporation is **WEBSTER GROUP, INC.**

ARTICLE II. DURATION

This corporation shall begin its existence on the 15th day of January, 1995.

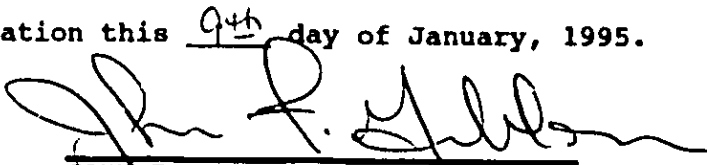
ARTICLE X. INDEMNIFICATION

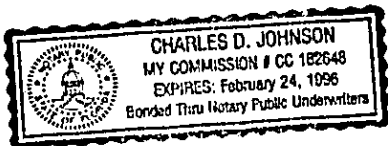
