ARTICLES OF INCORPORATION

OF

OGAZMUS, INC.

I, the undersigned, a natural person competent to contract, do hereby make, subscribe to, and file these Articles of Incorporation for the purposer of organizing a corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the Corporation shall be:

**ARTICLE II
GENERAL NATURE OF BUSINESS**

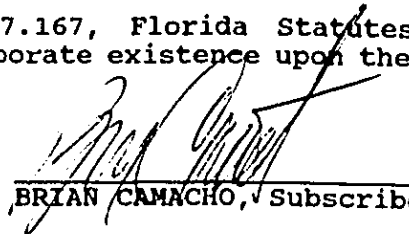

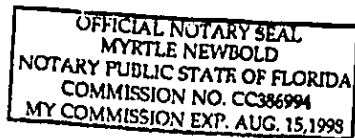
