



Pursuant to Section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article II is amended to read as follows: the principal place of business and mailing address of this corporation shall be 951 Broken Sound Parkway, Boca Raton, FL 33487.

2. Article III is amended to read as follows: the number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) without par value.

3. Article VI is added to read as follows: this corporation elects to have preemptive rights.

4. This amendment was adopted on the 28th day of August, 1996.

This amendment has been adopted by the sole director of this corporation's Board of Directors and the sole stockholder who owns 100 percent of the outstanding shares of the company in accordance with Section 607.1003, Florida Statute. The number of votes cast for these amendments by the shareholder was sufficient for approval.



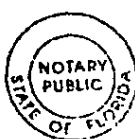
