The undersigned hereby agrees to organize a Professional Service corporation under the laws of the State of Florida and certifies that the Articles of Incorporation are as follows:

(a) The name of the corporation is:

RAYMOND S. SULLIVAN, D.D.S., P.A.

(b) The corporation shall have perpetual existence.

(c) The corporation may engage in:

The rendition of the same professional services that a dentist, including the practice of any specialties, duly licensed under the laws of the State of Florida, is authorized to render, provided however, that such professional services shall be rendered only through officers, employees and agents who are duly licensed or legally authorized under the laws of the State of Florida to render such services; and any activity or business permitted to Professional Service corporations under the laws of the State of Florida.

(d) The amount of authorized capital is:

(f) The corporation shall have one (1) director. The number of directors may be increased or decreased as provided in the bylaws.


