ARTICLE I. NAME

The name of this corporation is PEPPER BUSH FARMS, INC.

ARTICLE II. DURATION

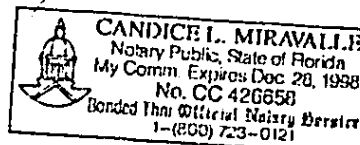
