The undersigned forms this corporation for profit in accordance with the Florida General Corporation Act.

ARTICLE I - NAME

The name of the corporation is **HEALTHCARE RESOURCE SYSTEMS**. INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of the corporation is:

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing of the date these Articles are filed with the Secretary of State.

ARTICLE IV - PURPOSES
