ARTICLES OF INCORPORATION

of

ARTICLE I

CORPORATE NAME

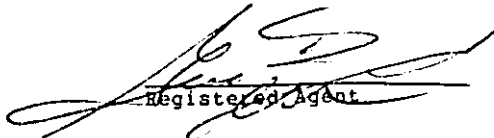
