ARTICLES OF INCORPORATION

OF

ALL AROUND TRAVEL, INC.

The undersigned, acting is incorporator of a corporation $\overline{\otimes}$ under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is All Around Trawel Inc..

SECOND: The period of duration of the corporation is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Capital Stock with a par value of \$.25 per share.
