ARTICLES OF INCORPORATION

OF

PARCEL Z-II, INC.

I. NAME

The name of the corporation is PARCEL Z-II, INC.

II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

III. CAPITAL STOCK
