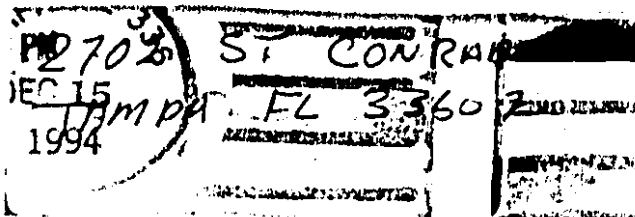

**ARTICLE OF INCORPORATION
OF**

MR. JACK'S TELEPHONE AND REPAIR SERVICE, INC.

I, the undersign, being desirous of forming a profit corporation, under the provision of Chapter 607 of the Florida Statutes, do agree to the following:

ARTICLE I-NAME

The name of the corporation shall be Mr. Jack's Telephone and Repair Service, Inc. of Tampa, Florida.

ARTICLE II-PRINCIPLE PLACE OF BUSINESS

The principle place of business and mailing address is 2702 St. Conrad St. Tampa, FL 33607.

ARTICLE III-PURPOSE

The purpose of the corporation shall be inclusive of, but not limited to the following:

1. To engage in all services related to the sale, service, installation and repair of telephones and related telephonic communication devices.
2. To invent, market and distribute any equipment of devices that relate to the telephone industry.
3. To borrow money, invest and reinvest its funds in such bonds, notes, and other securities, tangible or intangible, and as the corporation shall deem lawful and appropriate.
4. To obtain property, to be owned, rented and sold for profit.
5. To conduct educational and training activities designed to improve skills of a person and groups of people and to receive compensation for such activities.
6. To obtain information and research, studies and analyses of problems, and prepare and publish reports on such subjects as marketing, products, services, skill enhancement, sources of finance and any other such matters.
7. To exercise all other rights and powers conferred upon a corporation formed under the for profit laws of the State of Florida.
8. Dividends and profits will be distributed and divided among the sole proprietor and any share holders of the corporation.

ARTICLE IV BOARD OF DIRECTORS

This corporation will originally consist of one board member but will have no more than seven (7) board members.

1. The Board of Directors of this corporation may provide such by-laws for the conduct of its business and carrying out of its purpose as they may deem necessary.
2. The Board of Directors may present recommended changes to the by-laws and upon proper notice the by-laws may be amended, altered or rescinded by a majority vote of those members present at any regular meeting or any special meeting called for that purpose.

ARTICLE V-LIMITATION OF CORPORATE POWERS

1. The powers of the corporation of corporate powers limited only by the provision of chapter 607 of the Florida Statutes.
