ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
ORANGE STATE DOOR CONTROL, INC.  
(A Florida Profit Corporation)

Orange State Door Control, Inc. (the "Corporation") desires to amend its Articles of Incorporation, and pursuant to Florida Statute 607.1006, submits the following:

**FIRST:** The Articles of Incorporation were filed on January 13, 1995, and were assigned document number P95000005382.

**SECOND:** The following amendment to the Articles of Incorporation was adopted by the Corporation:

ARTICLE I of the Articles of Incorporation shall be replaced in its entirety by the following ARTICLE I:

**ARTICLE I**

1.1 **Name.** The name of the corporation is **OSDC, Inc.**

**THIRD:** The aforesaid amendment was adopted on March 1, 2014, to be effective as of the date of the filing of these Articles of Amendment.

**FOURTH:** The aforesaid amendment was approved by the sole shareholder and by the board of directors. The number of votes cast for the amendment by the sole shareholder and by the board of directors was sufficient for approval.
