

ARTICLE I. NAME

The name of this corporation is **WHITE MARLIN, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is Titusville,

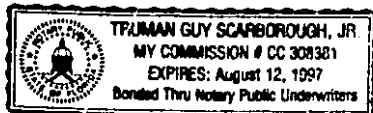
