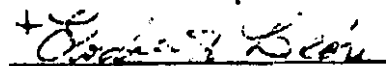
ARTICLE XI

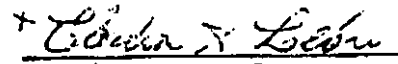

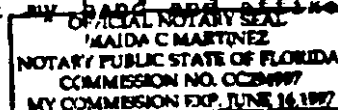
