The name and address of the initial registered agent is David A. Dunkin, 170 West Dearborn Street, Englewood, FL 34223-3290.

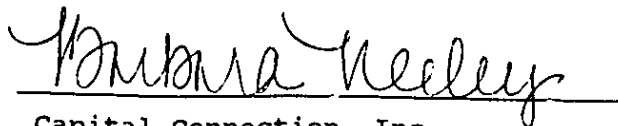
