The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE**  
**NAME**

The name of the corporation is VISTA LANDSCAPING, INC. and the principal office is located at 28 BENT WATER CIRCLE, BOYNTON BEACH, FLORIDA 33462.

**ARTICLE TWO**  
**DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE THREE**  
**PURPOSE**

The corporation may engage in any or all lawful business permitted to corporations under the laws of the STATE OF FLORIDA, or any other state, country, territory or nation.

**ARTICLE FOUR**
