WE, THE UNDERSIGNED, natural persons of legal age, ^{SECRET} acting as incorporators under the laws of the State of Florida, ^{SECRET} adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is CHARLES ANDERSON HOME SERVICES INC.

SECOND: The period of its duration is; **PERPETUAL**.

THIRD: The purpose(s) for which the corporation is organized is home services

and **ANY OTHER LAWFUL BUSINESS ACTIVITY FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER CHAPTER 607 OF THE FLORIDA STATUTES.**

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is **200 SHARES OF COMMON STOCK HAVING \$1.00 PAR VALUE EACH**.




