WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is CHARLES ANDERSON HOME SERVICES INC.

SECOND: The period of its duration is; PERPETUAL.

THIRD: The purpose(s) for which the corporation is organized is home services

and ANY OTHER LAWFUL BUSINESS ACTIVITY FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER CHAPTER 607 OF THE FLORIDA STATUTES.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 200 SHARES OF COMMON STOCK HAVING \$1.00 PAR VALUE EACH.

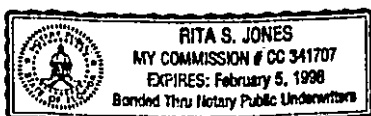
