ARTICLE ONE NAME

The term of existence of the corporation is perpetual.

ARTICLE THREE PURPOSE

The general nature and pur use of this corporation is to engage in the following activities:

The authority to engage in and transact, within A.) and without the State of Florida or the United States, any and all lawful activities permitted under the laws of the United States and/or of the State of Florida for which

B.) The Corporation may more particularly engage in the following businesses and/or activities:

2.) To engage in the business of wholesale and retail sales of any an.1 all merchandise including but not limited to clothes, shoes, accessories, fantasy jewelry, leather articles, purses, handbags & wallets of any kind, computers, commodities, durable goods and any and all other goods and merchandise of any 1 and nature including food of any kind and nature;

3.) To engage in the business of designing, creating and selling above mentioned articles from a designated location in the United States and throughout the world;

4.) To engage in any business or enterprise arising from or in connection with the sale of vending machines, merchandise, clothes, shoes, accessories, fantasy jewelry, leather articles, purses, wallets & handbags of any nature and kind, computers, commodities, durable goods and any and all other goods and merchandise of any kind and nature including food of any kind and nature;

5.) To engage in the business of importing and Exporting commodities, goods and any and all other materials,
