ARTICLES OF INCORPORATION
of
Quantum Edge International, Inc.

ARTICLE ONE. The Name of the Corporation is: Quantum Edge International, Inc.

ARTICLE TWO. The duration of the Corporation shall be perpetual.

ARTICLE THREE. The purpose for which the Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR. The aggregate number of shares which the Corporation shall have authority to issue is one hundred (100) shares of common stock with a par value of one dollar (\$1.00) each.

ARTICLE EIGHT. The Board of Directors is empowered to make, alter or repeal the Bylaws of the Corporation without restriction of their powers conferred by statute.


