OF

ARTICLE I - NAME

The name of this corporation is:

ALMED MEDICAL OFFICE, INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of United States and of this State.


ARTICLE X - EFFECTIVE DATE


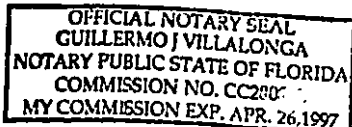
