The undersigned incorporator hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

MARIE A. HERRMANN, M.D., P.A.

The address of the principal office of this corporation shall be 575 Marmora Avenue, Tampa, Florida 33606, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in every aspect of the business of rendering the same professional services to the public that a Medical Doctor, duly licensed under the laws of the State of Florida, is authorized to render.

More specifically, the purpose is to operate a medical examiners office; to hire staff personnel and qualified practitioners in forensic pathology to perform such services; to acquire by purchase or otherwise all equipment, materials, supplies, and other property necessary in the operation and conduct of such medical examiners office; and to do all things necessary to carry out the purposes of the medical examiners office.

To act as a consultant in the field of general pathology or general medicine; and to act as an expert witness in the medical field.

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.
