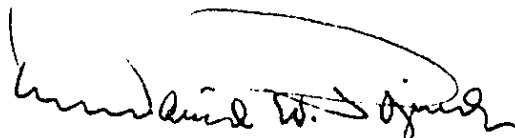

ARTICLES OF INCORPORATION

OF

INET MARKETING, INC.

The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is INET MARKETING, INC.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III
