We, the undersigned, are desirous of forming a corporation under the laws of the State of Florida, such laws that are applicable to corporations for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Certificate of Incorporation.

ARTICLE I

The name of this corporation shall be Crown Health Services Corporation and its principal place of business shall be 2530 N.W. 131ST Miami FL, 33167, and any location that the Board of Directors may deem appropriate.

ARTICLE II

The general nature of the business, objects and purposes to be transacted, promoted or carried on this corporation is to carry on a Health Services and any kind or type of business activity permitted under the laws of the State of Florida and Federal Statutes, as amended.




