The undersigned, acting as an incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is X-PIRATE, INC.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office of this corporation shall be 5318 Messina Drive, Lakeland, Florida 33813.

ARTICLE III. AUTHORIZED SHARES

The maximum number of shares that the corporation shall have the authority to have outstanding at any one time is 5,000 authorized shares of Capital Stock with a par value of \$1.00 per share.

ARTICLE VI. PREEMPTIVE RIGHTS

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such of the shares of the unissued stock of this corporation as may be issued for
