ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

SPOUSE ABUSE ASSISTANCE and shall include the

transaction of any and all lawful business for which corporations may be incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK
