ARTICLES OF INCORPORATION OF MARIDA ENVIRONMENTAL GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1

The name of this corporation is Marida Environmental Group, Inc. The principal office and mailing address of the corporation are: Suite 1101, 227 N. Bronough Street, Tallahassee, FL 32301.

Article 2

The duration of the corporation is perpetual.

Article 3
