ARTICLES OF INCORPORATION OF
MARIDA ENVIRONMENTAL GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1

The name of this corporation is Marida Environmental Group, Inc. The principal office and mailing address of the corporation are: Suite 1101, 227 N. Bronough Street, Tallahassee, FL 32301.

Article 2

The duration of the corporation is perpetual.

Article 3

The general purpose of the corporation is to engage in and to transact all business which is lawful under the laws of the United States of America and the State of Florida.

Article 4

The aggregate number of shares which the corporation is authorized to issue is one million (1,000,000) shares. All such shares shall be of a single common class. Each share shall have a par value of one dollar (\$1.00).

Article 5

The street address of the initial registered office of the corporation is c/o Mark Freund, Esq., Mark Freund, P.A., Suite 1101, 227 N. Bronough Street, Tallahassee, Florida 32301, and the name of its initial registered agent at that address is Mark Freund.

Article 6

The number of directors constituting the initial board of directors of the corporation is one. The number of directors may be increased or decreased from time to time in accordance with the corporation's bylaws but shall never be less than one. The name and address of the initial director is Robert S. Pettus, 523 Pointfield Drive, Millersville, MD 21108.

Article 7

The name and address of the incorporator is Mark Freund, Esq., Mark Freund, P.A., Suite 1101, 227 N. Bronough Street, P. O. Box 10171, Tallahassee, FL 32302.

Article 8

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment to them.
