## ARTICLES OF INCORPORATION OF J.L.M. RESTAURANT CORP.

ARTICLE 1. Name: The name of the corporation will be: J.L.M. RESTAURANT CORP.

ARTICLE 2. Term of Existence. This Corporation shall have perpetual existence.
