The Name of the corporation shall be DESIGN HOUSE, INC.

II

The duration of the corporation shall be perpetual.

III

The purpose for which the corporation is organized is to design houses and any other business allowable by law.

IV

The corporation shall consist of 100 authorized shares of stock with a par value of \$1.00.

V


