ARTICLES OF INCORPORATION

OF

CHRISTOPHER J. MALVANO, GENERAL CONTRACTOR, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation is Christopher J. Malvano, General Contractor, Inc. and its mailing address shall be 1017 Comstock Street, Port Charlotte, Florida 33952

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The primary purpose for which the corporation is organized is to provide services as a General Contractor together with any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation has authority to issue is 100, all of which shall be common shares with the par value of \$1.00.

ARTICLE V

ARTICLE VIII


